


## Weekly Tests - User guide

Trying to help candidates who have prepared for EQE 2020, we have developed a set of new questions, never published before, to help you assess the level of your knowledge.

It is a series of 10 weekly tests which should take less than 45 minutes a week, with random topics, that will go through all the main legal aspects of patent law needed for the exam.

### Taking a test

You can access the test from the Weekly Tests page. Choose the one you want to take and click **Start test**. The questions will appear in order. If the validity period of a test expired, you will not be able to access it. It is important to answer each of the tests within the validity period in order to have access to all of the questions. You can also choose directly the question that you want to answer. Once you have answered it, the question will appear with a strike-through.

### Answering questions

In order to give you more accurate feedback, we have developed an algorithm that considers more than simply checking whether your answer is correct or incorrect (which may be also based on luck). Therefore, it is extremely important to **add the legal basis** that you have used when you have decided on your answer. By adding at least 3 characters, a dropdown selection list will appear. Add all the legal basis that you have used. It is a valuable exercise when preparing for Paper D.

We also keep track of the time. Take the time that you need! In the end, you will find out what you have to do to finish in time during the real exam.

Submit your answer and go to the Next Question.
